- 5. The financial benefits of annual increment(s) falling due during the period of leave will be paid on resumption of duties after expiry of the granted without arrear.
- 6. She should inform his mailing address, fax number and his supervisor's address to this University after arrival in Belgium.
- 7. She should not overstay abroad except only for obtaining granting leave period.
- 8. She shall have submit a copy of his thesis at the library of this University
- 9. She shall be bound to obey the rules and regulations of this University during her period of leave.
