5. The financial benefits of annual increment (s) falling due during the period of leave will be paid on resumption of duties after expiry of the granted without arrear.

6. He should inform his mailing address, fax number and his supervisor's address to this University after arrival in Japan.

7. He should not overstay abroad except only for obtaining the Master's Program.

8. He shall have to submit a copy of his thesis at the library of this University

9. He shall be bound to obey the rules and regulations of this University during his period of leave.
