6. She should inform her mailing address, fax number and her supervisor's address to this University after arrival in the USA.
7. She should not overstay abroad except only for obtaining the PhD Program.
8. She shall have to submit a copy of her thesis at the library of this University
9. She shall be bound to obey the rules and regulations of this University during her period of leave.
