5. The financial benefits of annual increment(s) falling due during the period of study leave will be counted on resumption of duties after expiry of the leave granted without arrear.
6. He should not overstay abroad except granting leave period.
7. He shall to submit a copy of his thesis at the library of this University.
8. He shall be bound to obey the rules and regulations of this University during his period of leave.
